**For Inclusion In The Shortlist For The Tender For The
Phase 2 Reconfiguration/Refurbishment Of Existing Offices Contract**

1. Introduction and Background

The purpose of this Application Form is to enable S4C to short-list, from those Applicants who have completed this Application Form and submitted it to S4C in accordance with the conditions and instructions detailed below, a minimum of 5 Applicants (numbers permitting) to be invited to tender for the Phase 2 Reconfiguration/Refurbishment of Existing Offices Contract.

The scheme briefly comprises the remodelling and refurbishment of the ground and first floors of an existing office building including renewing Mechanical and Electrical installations, cutting openings in the structural concrete floor slab for a new staircase and platform lift. The anticipated contract period will be 20 weeks and the approximate value will be £1 million.

2. The Tender Process

Completion and submission of this Application Form in accordance with the conditions and instructions detailed below is the first stage of this tender process. Following this stage, those Applicants who are short-listed will be issued with an invitation to tender. Responses to the invitation to tender will need to be completed in accordance with the instructions set out in the invitation to tender and submitted by the deadline set out in the invitation to tender. Following a review of all tenders S4C will select the successful Applicant on the basis of the criteria set out in the invitation to tender.

3. Indicative Timetable for the Tender Process

4. Conditions of Participation

- 4.1 S4C is subject to the provisions of the Freedom of Information Act 2000 (“FOI Act”). Information supplied by any Applicant to S4C may be disclosable by S4C under the provisions of the FOI Act. If any Applicant considers that any information supplied by it pursuant to this Application Form is commercially sensitive or confidential in nature, it should identify this and explain the reasons why. Applicants should note, however, that identifying information as confidential or commercially sensitive does not guarantee that it will be exempt from disclosure. By completing and submitting this Application Form Applicants accept that S4C may disclose such information in response to any request under the FOI Act if S4C determines in its discretion that it is appropriate to do so.

Failure to provide any such information may result in exclusion from this tender process. - 5.2 If the Applicant is a company which is part of a group of companies, the questions in this Application Form and the information submitted must be answered by or in respect of (as the case maybe) the Applicant and not any parent or holding or other group company
- 5.3 The Applicant should attach, where appropriate, any supporting documents to this Application Form marking clearly the name of the Applicant and the number of the question in this Application Form to which the document relates.
